Requesting information regarding Ditropan 2.5 mg and 5 mg tablets. Were these approved Europe wide and via a centralized or a MRP and is or was Northern Ireland listed as an concerned member state.

MHRA Response

Ditropan Tablets 2.5mg (PL 45043/0035) and Ditropan Tablets 5mg (PL 45043/0036) were authorised to Neon Healthcare Limited following grant of a Change of Authorisation holder (CoA) on 13 October 2020. The original marketing authorisations for Ditropan 2.5mg Tablets (PL 00033/0124) and Ditropan 5mg Tablets (PL 00033/0125) were granted to Chauvin Pharmaceuticals Limited on 31 December 1993 following assessment via national procedures in the UK.
